4.1 Directly from you:

 - To analyse and improve our products, services, website(s) or information that we provide to you.
 - To measure the effectiveness of our and/or our wholesalers, retailers, suppliers' marketing communications.
 - To reach you and identify other similar people like you on social media who we believe would be interested in our products and services and to show them our content.
 - To provide you with the products, services or information you have requested, or that we feel would be of interest to you, and reasonably expected by you.
 - To analyse and report on trends in consumer behaviour, that helps us to understand our customers better, and predict future behaviour, so that we can engage with you directly or indirectly in an appropriate and efficient way.
 - To carry out the necessary administration services pertaining to yourself as a consumer and collect necessary payments from you.

- To send you an email(s) to check and see if there is any assistance we can provide or any problems you encountered pertaining to any of our products, services or any on-line forms on our website, Facebook Page, etc.
- To reach you with our latest news and information about our products, services and/or support service via online adverts, Facebook, Instagram, YouTube etc. based on your visit(s) to our FB page, Instagram Account, YouTube videos and o website.
